# Introduction

It is our intention to make King's College Doha a welcoming and accessible school to children and families from all sections of the community who have made the choice to educate their child/children in a coeducational British independent school overseas.

#### Our aim is:

- i. to provide a warm reception and access to excellent information about the school to all prospective parents and their children;
- ii. to support families throughout the Admissions process and as their child is admitted to the school;
- iii. to ensure that every pupil admitted to King's College Doha can access the full breadth and depth of the curriculum, both academic and co-curricular; and
- iv. to admit children who will benefit from a King's College Doha education.

# **Principles**

The admission of a pupil to the school will always be a fair and consistent process based on all the information that is available. An age-appropriate assessment on entry provides important data but we also ask that parents submit up to date, detailed reports from their child's current school/nursery. We appreciate that these might not be available for the youngest children who have not attended school/nursery.

Therefore, and in every case, our admissions process will ensure that we get to know your child well before being admitted to King's College Doha.

The following guiding principles are applied to each application received:

- i. Has the applicant successfully completed the application form in full, submitted the relevant documents and completed the age-appropriate entrance assessment?
- ii. Does the applicant have one or more siblings already enrolled at or applying to King's College Doha?
- iii. Does the applicant demonstrate additional talents or skills that can be developed further at the school, including but not limited to academic, sporting, musical, artistic, linguistic and leadership strengths?
- iv. Will the child be able to access the curriculum and benefit from a King's College Doha education?

# Minimum Age Requirement

An applicant is required to be three years of age of age on or before 31st August of that year to be age appropriate for entry to Pre-school.

#### **Transition**

Pupils enrolled at the school are expected to graduate to the next year group at the end of each academic year.

# Responsibilities

Admissions duties are overseen by the Admissions Department, which reports to the Principal. Any queries regarding entrance or admission should be referred to the Admissions Department in the first instance.

# **Enquiries and Applications**

#### **Enquiry**

- i. All parents who contact the school in-person, by phone or via the online enquiry form should expect to receive a welcoming reception and a prompt response normally on the same day.
- ii. Parents will be encouraged to make an appointment with the Admissions Department and attend a school tour/parent information meeting. Virtual meetings will be arranged for overseas families.

#### **Application**

- i. Parents are invited to submit an Application Form to the school.
- ii. Applications can be accepted:
  - Via the school's online Application Form
  - By submitting all relevant documents to a member of the Admissions Team at the school.

A one-off, non-refundable application fee is payable at the time of submitting your application. The application fee can be paid in cash, cheque or via bank transfer.

iii. Parents are required to submit copies of the following documents at the same time as making the application either in person to a member of the admissions team or via email to <a href="mailto:admissions@kingscollegedoha.com">admissions@kingscollegedoha.com</a>.

# Documents Required:

- National ID or Passport copy
- Valid Qatar ID card (for child and parents)
- Copy of the child's birth certificate
- Up-to-date health and immunisation documentation for the child
- Copies of the child's last two school/nursery reports (translated if not in English)
- Two recent passport-sized photos of the child
- Copy of relevant medical and educational psychologist's reports, as applicable
- iv. Reports from a child's existing school/nursery, will be obtained and read prior to the interview. In some cases, a confidential phone call to the existing school/nursery may be required to obtain further information. The school understands that school reports may be unavailable for children applying for Pre-School if they have not previously received formal education, but every effort will be made to obtain as much information as possible about a child before a place is offered.
- v. In cases when a pupil cannot be seen in school, pupils will be expected to complete assessments and entrance papers under the supervision of their current school. Reports from their current school will be obtained and a confidential telephone call to their existing school will be made to assess whether a place can be offered.

## Admissions Assessment and Interview

#### Introduction

An age-appropriate admissions assessment and interview is arranged once parents have submitted their application and when a space is available.

This is an opportunity for the Principal, Heads of School and other staff to meet the parents and the child/children and allows the school to assess whether they will benefit from a King's College Doha education.

# The Age-Related Admissions Assessment

**Pre-school and Reception (ages 3 years to 5 years):** The admissions assessment will comprise of an observation that will last approximately one hour. Our goal with our youngest children is to introduce the school environment in a fun, interactive and individual manner where children thrive, and enjoy challenges, rather than 'just cope'. We take school readiness very seriously. Readiness is primarily about emotional and social maturity – aspects of development that cannot be fast-tracked. As well as getting to know you as a family, we look for your child's ability to concentrate on an activity, listen to a story, play cooperatively with others, follow instructions, engage in conversation and show a measure of self-discipline and independence.

Year 1 and Year 2 (ages 5 years to 7 years): The admissions assessment will comprise a Taster Day, which will provide visiting children with an opportunity to experience a typical day in the Pre-Prep School whilst enabling embedded teacher observation throughout the day. As part of this experience, children entering Years 1 and 2 undertake an assessment of reading, phonics, Maths and writing, which is built into their time in the classroom.

Children who use English as an Additional Language (EAL) may undertake additional assessments to ascertain their level of English proficiency and therefore ability to access the curriculum.

Year 3 to Year 4 (ages 7 to 9): Children applying for Years 3 and 4 will also take part in a Taster Day, in which visiting children will experience a typical day in the Lower School and class teachers will participate in an embedded assessment process. This will allow us to see how your child concentrates on activities in class, interacts with others, follows instructions, engages in conversation and their levels of self-discipline and independence. Children who use English as an Additional Language (EAL) may undertake additional assessments to ascertain their level of English proficiency and therefore ability to access the curriculum. Children applying for these year groups also undertake an online assessment in English and Maths, and an interview with a member of the Senior Leadership Team. The interview will provide the school with an opportunity to learn more about the child's interests, skills and talents, as well as getting to know you as a family.

Year 5 and above (ages 9 to 17): Children entering Year 5 and above are also invited into school to participate in a Taster Day, in which they will experience a typical day in school and be assessed in the classes they join, throughout the day, by specialist teachers in school. Children applying for these year groups also take part in an online assessment in English and Maths, and an interview with a member of the Senior Leadership Team, the latter of which will provide the school with an overview of the child's hobbies and interests. Children who use English as an Additional Language (EAL) may undertake additional assessments to ascertain their level of English proficiency and therefore ability to access the curriculum.

Applications for places in Year 10 will be treated on a case-by-case basis; generally, however, the school reserves the right not to admit pupils directly to these year groups.

In addition to taking part in an assessed Taster Day, prospective pupils applying to join the Sixth Form (Year 12) are required to meet the minimum expectations of the school with regard to GCSE examination results. Those entering Year 12 for the 2023-24 academic year are subject to achieving a minimum of five (5) Level 6 grades at GCSE or the equivalent; a Level 7 will be typically required for access to any A-level Science courses; and a high Level 8 or Level 9 grade will typically be required for access to A-level Mathematics.

All offers to join the Sixth Form that are made to pupils undertaking GCSE examinations remain conditional until such point as the school has reviewed the results following their publication in August each year. For prospective pupils who are joining the school from a different system that does not require public examinations to be sat in Year 11 (or the equivalent grade), the school will assess the individual's suitability to join King's College Doha based on their performance in the Taster Day assessments and reports from the previous school.

## 8. English as an Additional Language

Pupils must be fluent English speakers in order for them to benefit fully from a King's College Doha education. Tuition in English as an Additional Language (EAL) will be a condition of an offer of a place at the school for pupils who are assessed on entry as requiring additional English language support. The school retains the right to require a pupil to attend EAL lessons where (in our opinion) we consider that the pupil does not have sufficient fluency of the English language to gain full access to the curriculum offered by the school.

# **Learning Support**

King's College Doha will consider applications from pupils with mild to moderate learning difficulties. Prospective parents are expected to discuss their child's learning needs and share any assessments/current individual learning plans with the admissions team and Principal as appropriate, and before making an application to the school.

Additional learning support will be arranged if the child is admitted to the school and it is felt they will be able to access the curriculum and benefit from a King's College Doha education.

#### Offer

Following the admissions assessment, the application form, assessment results and documentation including previous school reports, where available, will be reviewed by the school. This will result in one of the following:

a. An offer will be made for your child to be admitted to the school and the date of their admission will be confirmed.

or

b. You will receive a conditional offer for your child to be admitted to the school and the date of their admission will be confirmed.

or

c. You will be contacted by a member of the Admissions Department to discuss your application in more detail.

In the event of a pupil not being offered a place, or being offered a conditional place, the reasons in relation to their ability to fully access the curriculum and co-curriculum and thrive at the school will always be given and any conditions of the offer clearly articulated. The decision to offer a place is made by the Principal and his decision is final.

A member of the Admissions Department will contact parents once the offer has been made to answer any final questions and assist with completing the Acceptance Form as required.

A one-off, non-refundable Registration Fee is payable to accept an offer of a school place. An Acceptance Deposit must also be paid to accept and secure the place. This will be deducted from the school fees for the first term. Both the Registration Fee and Acceptance Deposit are payable within seven days of receipt of the offer letter.

# Accepting the Offer

To accept and secure the offer of a place at King's College Doha, parents must complete, sign and return the Acceptance Form to a member of the Admissions Team within seven days of the offer, together with the Registration Fee and Acceptance Deposit.

Acceptance of a place at King's College Doha is subject to parents agreeing to the School's Terms and Conditions, which will be made available to parents during the admissions process.
